Retention period of personal data

Knoop BV does not store your personal data longer than is strictly necessary to realize the purposes for which your data is collected, unless we have to keep data longer under a statutory regulation. When it comes to administration, such as the debtor and creditor



administration and the purchase and sales administration, we are obliged to keep this data for at least 7 years for the tax authorities.

Sharing personal data with third parties

We conclude a processing agreement with companies that process personal data on our behalf to ensure the same level of security and confidentiality of personal data. Knoop BV remains responsible for these processing operations.

Furthermore, we only share personal data if a legal obligation applies, such as the Pay Tax Act, the Poortwachter Improvement Act and the Chain Liability Act.
